Doug Ballard to discuss the South Maui Community Plan.

All presenters will have 10 minutes to speak followed by a 5 minute question & answer period.

Caleb will invite our local political representatives, Tom Cook (Kelly King), Terez Amato & Angus McKelvey, who will have tables set up where they may field questions from individuals after the presentations. Possibly a Maui Police Department representative may be included in this group.

Access: Keys to the main gate and cafeteria will be picked up ahead of time.

Food: Karen and Dawn will procure the refreshments with a budget of \$300 and secure the necessary plates, cups, napkins and serving utensils, some of which we have left over from last year.

Technology: Caleb and Daniel will set up and test all equipment necessary for the meeting presentations. Daniel will bring the MMNA PA system as a back up.

Directional signs: Daniel will make and place directional signs in the parking lot and at entrances to guide attendees to the cafeteria (Building D).

Check-in: We will try to stream line the check-in process by having many Board members at the entrance table, providing current membership list to each check in person along with benefits of membership brochure to give to non members. We will also use Venmo and Paypal along with accepting checks.

Election: Three board seats are up for election. If there are only three candidates a ballot vote will not be needed, but the three will be elected by affirmation. If there are more than three candidates a ballot election will take place with two Board members counting the ballots. Ballot cards will be handed out to members at the registration table at check in. Pens will be available if a vote takes place.

Clean up: After the close of the meeting all Board members will help with cleaning the floor, folding tables and dumping trash. The room must be put back the way we found it.
